# INTRODUCTION

## Content

This index lists all references in New Zealand Statutes and Gazettes relating to the constitution, status and boundaries of local authorities in New Zealand. In particular it lists references to:

- the constitution and abolition of territorial authority districts and regions:
- the alteration and definition of boundaries of districts and regions:
- changes of status (e.g. from district to city):
- changes of name (e.g. from Wanganui District to Whanganui District):

Also listed are the few instances of identified court judgements issued since 1989 relating to the definition of boundaries of districts.

The period covered by the index commences on 13 June 1989. This is because on that date a new system of local government was constituted by a series of Orders in Council<sup>1</sup>. Those Orders in Council were published in the New Zealand Gazette 1989, pages 2245 – 2529. References relating to the period from 1840 to 1989 are listed in a separate index.

## Structure of index

The index is divided into two sections:

To find a specific district or region choose one of the categories above and then select the district or region from the list.

## Unitary authorities

Five territorial authorities are also unitary authorities meaning that in addition to having territorial authority responsibilities, also have the responsibilities of a regional council.

Four unitary authorities have defined regions as well as territorial authority districts. They are Gisborne District Council, Marlborough District Council, Nelson City Council and Tasman District Council. Their regions are included in the "Regions" section of this index.

The other unitary authority, Auckland Council, does not have a separate territorial authority district and region. The Auckland Council has jurisdiction over a single area called "Auckland."

The Chatham Islands Council has a number of the responsibilities of a regional council but is not designated as a unitary authority.

## **Other types of boundary changes**

This index deals with changes that occur through a statutory process. Boundary changes can also occur through changes to the geography of an area. These are listed below:

- land reclaimed from the sea forms part of the district or region adjoining the reclamation<sup>2</sup>
- where a boundary is defined as being the coastline, e.g. at mean low water springs, accretion or erosion of the coastline has the effect of changing that boundary to follow the new line of the coast
- where a boundary is defined as being the middle line of a river following its natural course, the boundary will change if the natural course of the river alters.

Any such change occurs automatically and does not require statutory notification<sup>3</sup>.

In addition, if the boundaries of a territorial authority are altered and those boundaries are the same as regional boundaries, the boundaries of the region are altered accordingly (unless the Order in Council making the change provides otherwise)<sup>4</sup>. Although the change to regional boundaries is considered to happen automatically it is likely that an Order in Council altering boundaries will refer to the consequential change to regional boundaries.

## **Other changes**

The core purpose of an Act, Order in Council or notice (such as the constitution of a district or a new boundary) will remain in force either indefinitely or until explicitly altered or revoked by another Act, Order in Council or notice. Other matters provided for may cease to have effect after a certain period of time or be altered by other initiatives. For example:

- an Order in Council may provide that the initial administrative headquarters be in a specific location. If circumstances change a council may wish to change the location of its headquarters
- the initial representation arrangements of a new council are likely to be set out in the constituting Order in Council. These arrangements may change over time as a result of representation reviews required to be carried out under the Local Electoral Act
- an Order in Council may refer to functions, duties and responsibilities of a council under various Acts. Changes to those Acts may make those references redundant or require them to be read in a different way

- some provisions may have effect for a specified period, after which they become spent, e.g. a requirement that certain bylaws of a former council remain in force until a specified date.
